6. Residuary Power :

Subject to the provisions of these regulations, all regulations and condition as laid down in the ESIC (Recruitment) Regu-lations, 1965 as amended from time to time applicable to Group 'A' posts shall apply to the post specified in the sche-dule annexed to these regulations.

7. Savings :

Nothing in these regulations shall affect reservation, relaxation of age limit and other concessions required to be provided for the scheduled castes, scheduled tribes, ex-servicemen and other special cutegories of persons in accordance with the or-ders issued by the Central Govt. from time to time in this regard.
