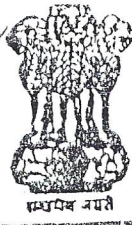

1)-1/65-Estt.1(Col.II).—In exercise of the powers by sub-section (1) of section 97, read with clause sub-section (2) and sub-section (2A) of that section section (2) of section 17 of the Employees' State Act, 1948 (34 of 1948) and in supersession of Employees' State Insurance Corporation (Recruitment) 1965 in so far as they relate to the post of Librarian and Library Assistant in the Employees' State Insurance Corporation hereby with the approval of the Central Government, the regulations regulating the method of recruitment to Librarian and Library Assistant in the Employees' State Insurance Corporation namely :—

Title and commencement :—

These regulations may be called the Employees' State Insurance Corporation (Library Staff) Recruitment Regulations, 1978.

They shall come into force on the date of their publication in the Official Gazette.

Application.—These regulations shall apply to the posts in column 1 of the Schedule annexed to these regulations.

Classification and scale of pay.—The number of posts, their classification and the scale of pay shall be as specified in columns 2 to 4 of the Schedule annexed to these regulations.

Recruitment, age limit, qualifications etc.—The number of posts, their classification and the scale of pay shall be as specified in columns 2 to 4 of the Schedule annexed to these regulations.

at the upper age limit specified for direct recruitment in the case of candidates belonging

to the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the order issued by the Central Government from time to time.

5. Disqualification.—No person,—

- who has entered into or contracted a marriage with a person having a spouse living, or
- who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to any of the said posts : Provided that the Director General of the Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this regulation.

6. Power to relax.—Where the Director General of the Corporation is of opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing and after obtaining the previous approval of the Central Government, relax any of the provisions of these regulations with respect to any class or category of persons.

7. Residuary matters.—Subject to the provisions of these regulations, all regulations and instructions applicable to other posts of corresponding category in the Corporation shall apply to the posts specified in the Schedule annexed to these regulations.

8. Savings.—Nothing in these regulations shall affect reservations and other concessions required to be provided for the Scheduled Castes and the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
