No. A-12(11)-2/87-Estt.I(A).—In exercise of the powers conferred by Sub-Section (1) of Section 97 read with Clause (xxi) of Sub-Section (2) and Sub-Section (2A) of that Section and Sub-Section (2) of Section 17 of the Employees' State Insurance Act, 1948 (34 of 1948) and in partial modification of the ESIC Recruitment Regulations, 1965, the Corporation hereby makes the following regulations, namely :—

SHORT TITLE AND COMMENCEMENT

1. (i) These Regulations may be called the Employees' State Insurance Corporation Recruitment (Amendment) Regulations, 1994.
- (ii) These shall come into force on the date of their publication in the official Gazette.
2. (i) The post of Jawadari/Dasnayi appearing in Sub-para (4) of proviso to Sub-Regulation (2) of Regulation 3 of the Employees' State Insurance Corporation (Recruitment) Regulations, 1965 published vide notification No. 1-1/1/60-Estt.I dated 3-4-1965 shall be deleted.
- (ii) Serial number 14 and entries against this serial number in the Schedule 2 to the Employees' State Insurance Corporation (Recruitment) Regulations, 1965, published vide Notification No. 1-1/1/60-Estt.I dated 3-4-1965 and subsequent insertions/substitutions/amendments made thereto from time to time, shall be deleted.

No. A-12(11)-3/92-EI(A).—In exercise of the powers conferred by Sub-Section (1) of Section 97 read with clause (xxi) of Sub-Section (2) and Sub-Section (2A) of that Section and Sub-Section (2) of Section 17 of the ESI Act, 1948 (34 of 1948), and in supersession of the ESIC Sr. Gestetnor Operator Recruitment Regulations, 1993 except in respect of things done or committed to be done before such supersession, the Corporation hereby makes the following regulations, regulating the method of recruitment to the posts of Sr. Gestetnor Operator, namely :—

1. SHORT TITLE AND COMMENCEMENT

- (i) These regulations may be called the Employees' State Insurance Corporation Sr. Gestetnor Operator Recruitment Regulations, 1994.
- (ii) These shall come into force on the date of their publication in the official gazette.

2. NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY

The number of posts, its classification and the scale of pay attached thereto, shall be as specified in column 2 to 4 of the schedule annexed to these regulations.

3. METHOD OF RECRUITMENT, AGE LIMIT, QUALIFICATIONS ETC.

The method of recruitment to the said post, age limit, qualifications and other matters relating to the said post, shall be as specified in column 5—14 of the said schedule.

4. DISQUALIFICATION

No person :—

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person :
- shall be eligible for appointment to the said post provided that the Director General of the Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this regulation.

5. POWER TO RELAX

Where the Director General of the Corporation is of the opinion that it is necessary or expedient so to do, he/she may, by order, for reasons to be recorded in writing and after taking the prior approval of Central Government, relax any of the provisions of these regulations with respect to any clause or category of persons.

6. RESIDUARY MATTERS

Subject to the provisions of these regulations, all regulations and conditions as laid down in the ESI (Recruitment) Regulations, 1965 as amended from time to time, applicable to the corresponding categories of posts in ESI Corporation, shall apply to the posts specified in the schedule annexed to this regulation.

7. SAVINGS

Nothing in these regulations shall affect reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, the Scheduled Tribes and other special categories in accordance with the orders issued by the Central Government from time to time.
