No. A-12(11)-3/2001-Estt. I(A) - In exercise of the powers conferred by sub-Section (1) of section 97 read with clause (xxi) of Sub-Section (2) and Sub-Section (2-A) of same the Section and Sub-Section (2) of Section 17 of the ESI Act, 1948 (Act No. 34 of 1948) (as amended), the Corporation hereby makes, the following Regulations regulating the method of Recruitment to the post of Assistant Legal Advisor in the ESI Corporation, namely:-

1. **SHORT TITLE & COMMENCEMENT:**

- i. These regulations may be called the ESI Corporation (Assistant Legal Advisor) Recruitment Regulations, 2003.
- ii. They shall come into force on the date of their publication in the Official Gazette.

2. **NUMBER OF POSTS, CLASSIFICATION & SCALE OF PAY:**

The number of posts, their classification and the scale of pay attached thereto, shall be as specified in columns 2 to 4 of the Schedule annexed to these Regulations.

3. **THE METHOD OF RECRUITMENT, AGE LIMIT, QUALIFICATION ETC.:**

The method of recruitment, age limit, qualifications and other matters relating to the said post, shall be as specified in columns 5 to 14 of the said Schedule.

4. **DISQUALIFICATION:**

No person :-

- (a) who has entered into or contracted a marriage with a person having spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person.

shall be eligible for appointment to the said post provided that the Director General of the Corporation may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these Regulations.

5. **POWER TO RELAX:**

Where the Director General of the Corporation is of the opinion that it is necessary or expedient to do so, he may, after taking prior approval of the Central Government and in consultation with the Union Public Service Commission, by order, for reasons to be recorded in writing, relax any of the provisions of these Regulations, with respect to any class or category of person.

6. **RESIDUARY MATTERS:**

Subject to the provisions of these Regulations, all other regulations and instructions, laid down in E.S.I. Corporation (Recruitment) Regulations, 1965, as amended from time to time, applicable to the corresponding category of Officers in the Corporation, shall apply to the post specified in the Schedule annexed to these Regulations.

7. **SAVINGS:**

Nothing in these Regulations shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, OBCs and other categories of persons in accordance with the orders issued by the Central Government from time to time, in this regard.
