Sub: **ESIC** जूनियर रेसिडेंट (**ESIC JR**) बॉन्ड के तहत सेवाओं के रूप में **BDS** पास आउट की तैनाती / **Deployment of BDS Pass-outs as ESIC Junior Resident (ESIC JR) under ESIC Residency Scheme for utilization of services under bond - regarding.**

In continuation of Office order No. 08 of 2023 dated 12.09.2023, the undersigned is directed to refer to the captioned subject and to inform that the Competent Authority is pleased to deploy the BDS Pass-outs from ESIC Dental Colleges as ESIC-JR under bond (as per list attached).

The terms and conditions for ESIC-JR will be as under:

1. The candidate is deployed as ESIC-Junior Resident (ESIC-JR) under bond and will be governed under ESIC Residency Scheme.
2. Their remuneration will be governed under ESIC Residency Scheme, in Level 10 (7th CPC) with initial pay Rs. 56100/- corresponding to PB-3 with Grade Pay of Rs. 5400/- (pre-revised).
3. The dental Bond JRs will be governed by the Hqrs memorandum - No.L-11/12/3/Release from Bond/ESICJR/MEC dated 10.08.2023 w.r.t. bond duration. (Copy enclosed.)
4. The deployment / posting of BDS Pass-outs has been done in public interest, subject to fulfilment of condition under bond as circulated vide Memorandum No. L-11/12/3/2018/ Corp.Cell/MEC(PF) dated 28.07.2020.
5. The candidate is liable to be transferred anywhere in India under ESI System in public interest.
6. The candidate has to report for joining to the Dean / Medical Superintendent of the concerned location within 15 days of issue of this order or 15 days after completion of internship (whichever is later). The period of compulsory bond service shall commence from the forenoon / afternoon of the date of joining, at place of posting.
7. The candidate shall be bound to fill 'Declaration as per NMC / DCI norms, if required.
8. Dean / Medical Superintendent of the concerned location is authorized to exercise the powers of Competent Authority in all administrative / disciplinary matters for ESIC-JRs.
