- 2. Reservation will be as per Government of India guidelines issued from time to time.
- 3. <u>As per EWS guidelines posts are not carried forward, hence; in case of non- availability of EWS candidate; other category candidates may be allowed provisionally to apply for the post subject to the condition that they will be considered for the post as an UR candidates & the selection will be only on merit basis.</u>

- 5. All Candidates must have up-dated Medical (NMC/ State Medical Council) with all post MBBS/ MD/ MS Qualification(s). - 6. Candidates working in Govt./ Autonomous/ Statutory Institution should preferably have "NOC" at the time of walk- in- interview from their Employer. In case of immediate non- availability of the same, copy of "applied for NOC" to be submitted at the time of walk- in- interview.
- 7. No private practice is allowed in any capacity after joining as Contractual Assistant Professor at ESIC Medical College, Bihta.

1. Age Limit as on 30.06.2025: 69 Years (Not Exceeding)

Note:

- a) The maximum tenure of such engagement will be till 70 years of age for Contractual Assistant Professor whichever is earlier provided other rules & regulations are satisfied.
- b) The EWS candidates should submit EWS Certificate as per Annexure- I of Govt. of India, Ministry of Personnel, Public Grievances & Pensions, DOPT Office Memorandum No. 36039/1/2019-Estt (Res), dated 31.01.2019.
- c) The OBC (Non-Creamy Layer) Certificate should be issued and not prior to 01 (One) Year from the date of walk- in- interview. It has to be as per the format applicable for job in Govt. of India and to be issued by an Officer not below the rank of Sub-Divisional Officer (अनुमंडल पदाधिकारी) or Equivalent Authority of the concerned State for Central Govt. job.
- d) Reservation for PH (Divyangjan) Candidate will be maintained as per GoI norms.
- 2. Educational Qualifications: As per NMC (MCI) guidelines.
- 3. Pay and Allowances: Assistant Professor: Fixed Basic Pay of 67,700/- and other allowance as admissible. Monthly Pay will be paid according to data available in Biometric Attendance System regarding attendance marked by the person concerned for his/her working hours.
