- **1.** Duly filled Annexure A
- 2. Two Passport Size Photographs
- 3. Two sets of self-attested of the following documents along with Originals.
  - (a) Proof of Date of Birth
  - (b) SSC/10<sup>th</sup> Standard Certificate or equivalent.
  - (c) Certificates in support of Educational Qualification
  - (d) Registration Certificate with concerned Medical Council or State Government Registration.
  - (e) Caste Certificate (if applicable)
  - (f) Experience Certificate.
- 4. The appointment will be purely on contractual basis and initially for a period of one year or till the joining of regular incumbent (whichever is earlier). The engagement can also be short closed before one year if the performance is not found satisfactory or the vacancy ceases to exist.
- 5. Vacancies are likely to change depending upon actual requirement at the time of Interview.
- 6. In case of serving candidate, No Objection Certificate from the present employer shall be produced at the time of Interview.
- 7. No TA/DA will be paid to candidates for appearing in the Interview.
- 8. The Medical Superintendent reserves the right to fill up all or any of vacancies or post.

- 11. Private practice of any kind will not be allowed to Senior Residents and Full Time Specialist.
- 12. Homeopathy Physician and Ayurveda Physician are also not allowed of any private practice during the working hours at ESIC Model Hospital Cum ODC, Andheri East, Mumbai 400093.
- 13. Hostel accommodation/Quarters will not be provided.
- 14. The appointment shall not confer any right or preference for regular appointment in Employees' State Insurance Corporation.
- 15. The decision of the selection board will be final in all aspects of selection and no further correspondence will be entertained under any circumstances.
- 16. The payment of remuneration shall be guided by Employees' State Insurance Corporation, Headquarters office, New Delhi.
- 17. In case of selection the selected candidate requires to sign a contract agreement on the Stamp Paper of Rs. 100/- (One Hundred Only). The cost of stamp paper shall be bear by the candidate.
- 18. The contract agreement can be terminated by either party by giving one month written notice to other party. The agreement can also be terminated by depositing/paying an amount equivalent to one month remuneration to other party.
- 19. For Senior Resident 3 Year, Full Time Specialist & Full Time Super Specialist, selected candidates should deposit of Rs. 30,000/- (Thirty Thousand Only) and Homeopathy Physician, Ayurveda

Physician & Part Time Super Specialist should deposit of Rs. 10,000/- (Ten Thousand Only) as security deposit by Demand Draft, which would be forfeited towards administrative expanse if the candidate resigns without notice.

- 20. Candidate who have already worked as Senior Resident for 03 Years after PG under Central Residency Scheme in any government organization are not eligible to apply for the post of Senior Residents on contract basis under 3-year Senior Residency Scheme.
- 21. If any candidate wishes to appear for more than one post, he/she must appear with separate sets of application forms, documents, photograph and separate demand draft (if applicable) for each post applied.
- 22. In case of any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to the engagement, he/she will be liable to be removed and any action deemed fit will be taken by the Competent Authority at any stage.
- 23. In case of non-reporting of the provisionally selected candidates, the next candidate in order of merit of respective category may be selected in the concerned department.
